- Nominating Committee Report: The Executive Committee nominating committee members (Tony Hyde, Rosemary Baker-Monahan, Michele Bradley and Marsha Kirk) met on October 20 to make officer recommendations to the Board. The committee recommends the following officers to be voted on January 12, 2023: President: Commissioner Lianne Thompson; Vice-President: Commissioner Casey Garrett; Secretary/Treasurer: Commissioner Erin Skaar; At-Large: Commissioner Jerry Willey.
- CEDS Adoption. Adopted with no objections the 2022-2027 CEDS as presented during the September 8 2022 Board meeting. (LT/JW)
- EPA Policies Addendum--Adopted to be applied to the management of ColPac's EPA Brownfield Revolving Loan Fund as an attachment to our current policies and procedures. (SJ/MK)
- EPA Brownfield RLF Banking Resolution—Approved with no objections. (TH/JW)
- Ayreann introduced new staff, Calvin LeSueur. Calvin will be assisting part-time with operations and administration.
- Board members said farewell to departing members Commissioner Henry Heimuller and Mayor Bruce Jones.

#### AGENDA ITEM-4 Other Business/Project Updates

- Karen Sanders, Dean of Advanced & Applied Technologies for PCC Oregon Manufacturing Innovation Center (OMIC) discussed programs at the campus. Her presentation can be found here.
- Juliet Hyams presented an <u>update</u> of the Rural Capacity program. The program's funding, approved by the legislature, will expire in 2023 unless renewed.

#### **AGENDA ITEM-5 Member Updates**

- H. DeSart: The NOW Board is in search of private sector members. Members can be from any part of the region but preferably represent maritime, healthcare, manufacturing or leisure and hospitality.
- B. Jones: Astoria's library bond passed to complete renovation. City Council passed housing density code changes
  and approved a new enterprise zone at Tongue Point. Coast Guard plans to build new pier at Tongue Point and
  develop a child development center. The new city manager, Scott Spencer starts on January 1 as well as the new
  mayor, Sean Fitzpatrick.
- F. Spence: The Port of Astoria also approved the enterprise zone and is supportive of the jobs that will be created at Tongue Point.
- M. Olson: Working with Astoria on 200+ housing units at Tongue Point. Would like to bring Coast Guard and
  private developers into the meeting. Astoria has been able to find a one-year solution to the brewery waste issue.
  Working with Columbia Economic Team on a new business recruitment.
- T. Hyde: The region will need to advocate for the continuation of enterprise zone incentives during the legislative session.
- S. Wright: ColPac staff presented at the Seaside Chamber and Downtown Association recently. Seaside is hosting a coastal housing summit on December 6.
- M. Kirk: Banks is redoing its water master plan, down to 10% loss. Working with businesses on façade improvements through Urban Renewal. Working on expanding parking at the Banks-Vernonia trailhead.
